**HONORING THE LIVES LOST ON JANUARY 29, 2025.**

Yesterday marked the one-year anniversary of the devastating midair collision involving American Airlines Flight 5342 and a U.S. Army helicopter over our nation's capital, which claimed sixty-seven lives. There were no survivors. These were daughters and sons, husbands and wives, parents, and friends. They were people who boarded a flight expecting to arrive safely. We owe them more than remembrance; we owe them action.

As Americans, we trust that when we book a flight, our safety is protected from takeoff to touchdown. That is why I introduced the House companion to the ROTOR Act: to do my part to make our skies safer and to prevent tragedies like this from happening again.

Following a comprehensive investigation into the January 29, 2025 collision, the National Transportation Safety Board identified serious systemic failures. One of the NTSB's key recommendations was clear: require all aircraft operating in airspace where ADS-B Out is mandated to also be equipped with ADS-B In, providing pilots with real-time traffic awareness and audible alerts in the cockpit. The ROTOR Act directly answers that call.

This legislation ensures that most military aircraft transmit their precise location when not participating in a critical mission. It also requires ADS-B In for aircraft operating in high-risk, high-volume airspace to enhance pilot situational awareness. These are practical, proven safety measures that save lives.

I am encouraged and grateful that the Senate has passed Senator Cruz's ROTOR Act. This is responsible, bipartisan legislation that reflects our obligation to protect the American people. I am deeply proud to be leading the effort in the House to get this bill across the finish line—because honoring the sixty-seven lives we lost on January 29, 2025, means ensuring that our skies are truly safe.

**JANUARY CONSTITUENT SERVICES SUCCESS**


